<p>1. Purpose</p>	<p>Transportation for students shall be provided in accordance with law and Board policy.</p>
<p>2. Authority</p> <p>Title 22 Sec. 23.1, 23.2, 23.4, SC 1361, 1362</p> <p>SC 1362</p> <p>Title 22 Sec. 23.3 SC 1374</p> <p>SC 1361</p>	<p>The Board shall purchase, equip, and maintain vehicles and/or contract for school bus services for transportation of students to and from school at regularly scheduled hours and for field trips and extracurricular activities.</p> <p>The Board shall provide transportation for students living within the prescribed limits when walking conditions to the school are found to be hazardous by the Department of Transportation.</p> <p>The Board shall transport handicapped students without regard to distance or hazardous walking conditions.</p> <p>The Board shall transport eligible resident students who are enrolled in nonpublic schools within the distance prescribed by law.</p>

Delegation of Responsibility</p> <p>Title 22 Sec. 23.4</p> <p>Title 22 Sec. 23.4</p> <p>Title 22 Sec. 23.4</p>	<p>The school bus driver shall be responsible for the discipline of students while they are being transported.</p> <p>The principal may suspend a student from bus transportation for disciplinary reasons, and the parents shall be responsible for the student's transportation.</p> <p>The Superintendent or designee shall be responsible to:</p> <ol style="list-style-type: none"> 1. Promulgate rules governing the number of chaperones to accompany students in connection with school related activities. 2. Prepare a district map or schedule indicating each bus stop and bus route.

<p>Title 22 Sec. 23.1, 23.4</p>	<p>3. Maintain records and make required reports regarding school transportation.</p>
<p>Title 22 Sec 23.4</p>	<p>4. Promulgate rules governing student conduct during transport; such rules shall be binding on all students transported by the district.</p>
<p>4. Guidelines Title 22 Sec. 23.6</p>	<p>In addition to the pupils (students) being transported on the school bus the only others permitted are board approved drivers and other school authorized personnel. Failure to comply with this policy may result in suspension or termination of the driver.</p>
<p>Crimes Code 18 Pa. C.S.A., Sec. 5517</p>	<p>While transporting pupils all bus drivers shall order those who enter a bus without authorization by the Board of School Directors to disembark. If the unauthorized person refuses to disembark from the bus he/she commits a misdemeanor of the third degree. If a bus driver fails to inform the unauthorized person to disembark from the bus he/she may be suspended or terminated.</p>
